SECTION 1 - EXECUTIVE SUMMARY

1.1 General

Cosset Consultants was appointed by the National Universities Commission as Procurement auditors to review the procurement activities of the Africa Centre of Excellence for Mycotoxins and Food Safety (ACE-MFS), Federal University of Technology, Minna. It is one of the 17 Second Africa Higher Education Centres of Excellence for Development Impact (Ace-Impact) Projects.

1.2 Aim

The primary aim and objective of this Procurement Process Audit is to review the procurement, contracting and implementation processes and determine the extent to which laws guiding the procurement activities are complied with; and confirm their consistency with the ACE-Impact institutional guidelines and the World Bank general guiding principles. This audit also helps to identify non-compliances and deficiencies in the procurement activities and proffer appropriate corrective measures

1.3 Methodology and Review Procedure

1.3.1 Methodology

The methodology and approach adopted for this post review are in three phases:

- i. Inception activities.
- ii. Field works/activities.
- iii. Preparation and presentation of audit reports.

Generally, these phases included the determination of scope of assignment and selection of contracts to review. The study and evaluation of the Project/Contract files and other documents. Interactive meetings with the procurement staff. Data collection and analysis; physical site inspections; and the preparation of inception, draft and final procurement audit reports.



1.3.2 Review Procedure

The Terms of reference noted that the Borrower and Bank agreed that the ACE-Impact Centres should use the Institutional guidelines in the implementation of the project'. That notwithstanding, the report considered the level of compliances to the Banks guiding principles.

1.4 Contract Packages and General Procured items

ACE-MFS has a total package contract size of fourteen (14) items. This is made up of twelve (12) items of goods, one (1) work and one (1) service as shown in procured inventory table, appendix 1

1.4.1 Procurement Methods for Packaged Procurements

The dominant method used for the procured contracts was shopping (SH), using Request for Quotation (RFQ), that has 86% representation with twelve (12) items, National Competitive Bidding (NCB) was used once, shopping/Request for Proposal, and Direct Contract (DC) was used once as well as figure 1 below.

1.4.2 Procurement Types for Packaged Procurement

The procurement types were, twelve (12) items of goods at about 86%, one (1) work at 7% and one (1) service item at 7% as shown on table 2 and illustrated in figure 2.





1.4.3 Sample Size

The audit sample size was determined by random sampling of the procured contracts. The selection considered the various procurement methods used, as well as the procurement types. The sample size of 50% is made up of seven (7) items as in figure 3. One (1) item was procured using NCB process and it make up 15% of sampled contracts. One (1) item was procured through RFP and that represent 15% of the sample size, and five (5) items through Request for Quotation at 70% of sample size as in figure 4

The total value of awarded contracts was N956,593,642.91. The seven (7) reviewed procurements have a sample value of N623,094,154.61 being about 65% of the total contract package procured.








1.5 Findings

- The Centre of Excellence for Mycotoxin and Food Safety (ACE-MFS), used the University's procurement guideline and the Public Procurement Act (2007) as amended in the procurement activities.
- 2. The items procured are in the approved procurement plan. (Appendix 3)
- ACE-MFS obtained 'No Objection" from the Bureau of Public Procurement (BPP) to used selective procurement processes for all the contracts except for the Construction of the ACE-MFS complex, were advertisement was placed in the Federal Tenders Journal of July 11, 2022.
- About fourteen (14) procurement activities were presented as having been carried out by the Centre from inception of the ACE-Impact up to April 30, 2023.
- 5. The information collected from the Centre, showed that the contract amount on the fourteen (14) package procurements is a gross value of about N956,593,642.91 (about USD2,321,547.49) as at April 30, 2023. Seven (7) contracts were reviewed (Appendix 1). The seven (7) reviewed contracts have a total value of N623,094,154.61, consisting of five (5) Goods, one (1) Work and one (1) Service.
- 6. Some of the conditions issued by the BPP for approving the request for "No Objection" were that (i) Vendors should not bid for more than one lot. (ii) Where it is required, all bidders should show evidence of authorization from Original Equipment Manufacturers (OEM).
- 7. Each vendor bided for up to seven (7) lots.
- One supplier was awarded contract for five (5) out of the seven (7) lots. The other two (2) lots were won by one other supplier.
- Only three (3) of the procured items are still in progress and one of them is the construction of the ACE-MFS Building Complex. One (1)

has had the procurement process completed, and award made, but the letter has not been issued to the preferred bidder because, there was no fund.

- 10. The bids and items were subjected to evaluation and checked for price competitiveness. The prices competitiveness was positive.
- 11. Approved Standard Bidding Documents (SBD) were used for the procurements.
- 12. Contracts were presented and approved by the appropriate approval authority. The analysis and evaluation of tenders were substantial.
- The Centre has qualified procurement staff some of whom alternate between the Centre and the University's procurement department (their primary place of assignment).
- 14. On the average, payments were seen to have been made within reasonable time, from date of application to the date of payment.
- 15. The suppliers and contractors used by the Centre complied with the mandatory requirements. The database of these vendors is domiciled at the University's central procurement Department.
- 16. Works at the Construction site of the ACE-MFS Building Complex was satisfactory.
- 17. Retrieval/supply of procurement documents and information was seamless. The documents were substantially well stored and easily retrieved.
- 18. Withholding Taxes (WHT) and Value Added Taxes (VAT) were deducted and evidently remitted to the relevant tax authorities.
- 19. The unsuccessful bidders were not seen to have been notified of the award of the various contracts.

1.6. Rating and Classification

The audit review opinion is classified and rated as shown on table 4 below

1.7 Audit Opinion

The procurement activities of ACE-Impact projects, the ACE-MFS, Federal University of Technology, Minna **NEEDS IMPROVEMENT**. The opinion is based on consideration of compliances to the institutional guidelines, the Public Procurement Act 2007 and the WB general procurement principles, where strongly required as shown in table 5. ACE-MFS is considered to have achieved seventy (70%) mark.

1.8 **Recommendations**

1. When the Centre approached the BPP for No Objection approval that was granted, the Centre was wrong for not following the conditions upon which the approval was based. (i) It was only right that the respective bidders should have had credible OEM before being considered responsive to bid. (ii) bidders should have been restricted to bid for not more than one lot.



- 2. One supplier won the awards for five (5) of the seven (7) lots. It was against the BPP condition that bidders should not bid for more than one lot. However, the Centre explained that this was because there were very few companies that have OEM authorization; also bearing in mind that the good is not off-the-shelve product. It so happened that the vendor that won the five (5) contracts offered the lowest responsive bids. The explanation was understandable.
- Contract package identification is very important in contract management and it should always be applied to all proposed contracts.
- 4. The Centre should be mindful of commencing the process of an award of contract for which the fund is not available. A case in hand is the process that culminated in a preferred bidder that has the letter of award ready since August 2022 but not issued out. Unless an agreement was extracted from the bidder that the price would not change, it would mean that the process was in vain bearing in mind that the bid validity period has expired.
- 5. Unsuccessful bidders should always be debriefed. This makes them to be aware of their lapses and would help to create a healthier procurement environment through improved levels of competition.
- 6. Continuous procurement training for staff of the Centre will improve the qualities of deliveries at every stage of the programme. This will enhance their understanding of the general procurement guidelines and principles.
- 7. Some documents were sent to the BPP for compliance reviews; upon which the "No Objection" approval to the Centre was based. Such documents should always be retrieved and kept with the Centre in case of activities such procurement audit.
- 8. The performances of the reviewed contracts are detailed in the specific contracts reviews below.

SECTION 2 – INTRODUCTION

2.1 BACKGROUND

Due to the need to promote regional specialization amongst Universities in the West and Central Africa sub-region within disciplines that address particular common regional challenges, the Africa Center of Excellence (ACE) Project aims at strengthening the capacities of these Universities to enable them deliver high quality training and applied research.

1. Africa Centre of Excellence (ACE 1) Project

The Africa Centre of Excellence (ACE 1) project was instituted in 2013 by the Government of Nigerian, Ghana, Benin Republic, Togo, Burkina Faso, Cameroun and Senegal with support from the World Bank.

The Federal Government of Nigeria (FGN) entered into a credit agreement (Credit Number 5415-NG) after securing US\$70.0 million with the International Development Agency (IDA) of the World Bank (WB) to finance the ACEs project in 10 Nigerian Universities.

2. The Second Africa Higher Education Centres of Excellence for Development Impact (ACE- Impact) Project

The Second Africa Higher Education Centres of Excellence for Development Impact (ACE- Impact) Projects resulted from the successes achieved with the ACE 1. ACE-Impact project has 43 Centres in the Africa sub-region, with 17 of them being run by Nigeria Universities.

ACE-Impact project (Credit Number 6510-NG) was designed to inject \$115 million to the Nigeria University System (NUS).

2.2. THE AFRICA CENTER OF EXCELLENCE FOR MYCOTOXIN AND FOOD SAFETY, (ACE-MFS,) FEDERAL UNIVERSITY OF TECHNOLOGY, MINNA.

ACE-MFS's goal is "to be a global food safety training and research authority in order to realize sustainable and secure health for humanity".

The Centre's noted that "the creation of the Africa Center of Excellence for Mycotoxin and Food Safety will create learning opportunities and research results to address Africa's shortage of expertise and applicable solutions to ensure a safe, controlled and sufficient food supply that will support economic growth and public health".

2.3 NATIONAL UNIVERSITIES COMMISSION (NUC)

The **National Universities Commission (NUC)** of Nigeria is a parastatal under the Federal Ministry of Education (FME). It was established in 1962 as an advisory agency in the Cabinet Office and became a statutory body in 1974. NUC is a regulatory agency acting as a catalyst for positive change and innovation for the delivery of quality University education in Nigeria.

The **NUC** aims to: achieve a stable and crisis-free University System; upgrade and maintain physical facilities in the Nigerian University System for delivery of quality university education and match university graduate output with national manpower needs; work with Nigerian Universities to achieve full accreditation status for at least 80% of the academic programmes; foster partnership between the Nigerian University System and the private sector.

The National Coordination of the ACE-Impact projects is domiciled at the National Universities Commission (NUC). It is responsible for the National Project facilitation, training, and supervision in fiduciary aspects as well as national Monitoring and Evaluation (M&E) and minor Technical Assistance (TA) in Nigeria.

2.4 WORLD BANK PROCUREMENT GUIDELINE

The WB guideline has set rules guiding the procurement processes to be followed for procurement of good, works, consulting and non-consulting services being financed with loans from the WB. It covers the consideration of the WB core procurement principles in every contract.

Notwithstanding the established procurement guidelines, the FG/NUC and the WB have agreed to allow the ACE-Impact Centres to use the various institutions guidelines for the implementation of the projects.

2.5 PUBLIC PROCUREMENT ACT (PPA) 2007

The Public Procurement Act 2007 as amended guides all procurement activities of the Ministries Departments and Agencies (MDAs) in Nigeria. The PPA is regulated by the Bureau of Public Procurement (BPP). One of BPP's functions is to regulate and ensure the reduction of infractions, weaknesses and non-compliances aimed at reducing corruption in public procurement. It also aims to ensure value for money, economy, transparency, competition, fairness, integrity and accountability in public procurement activities; improved professionalism and enhanced service delivery.

The PPA Act 2007 as amended provides the basic framework for the award and execution of contracts in Nigeria and promotes freedom of information that mandates all unclassified procurement records to be made available to appropriate public for inspection.

2.6 PROCUREMENT PROCESS AUDIT OF ACE-IMPACT PROJECTS

The purpose of the Procurement Audit of ACE-Impact is to study, verify, interpret, and critically analyze all data, documents and Procurement statement collected/received and form true, fair and independent opinion on the Procurement Statements of the Procurement operation of ACE (Nigeria) for the period under review and to report findings to the National Universities Commission (NUC).

2.7 OBJECTIVES OF THE ACE-IMPACT PROJECT PROCUREMENT PROCESS AUDIT

This Procurement Audit is to identify and report on negligence in procurement management operations and decisions. It is also structured to bring to light all fraudulent acts, weaknesses, deficiencies and noncompliances that negatively affect procurement activities and recommend deterrents and corrective actions to ensure improved processes. The Procurement audit gave objective assessments of the procedures specified in the Credit Agreement and determine the levels of compliances with institutional guidelines with respect to the considerations of the World Bank procurement guiding principles.

2.8 ENGAGEMENT OF COSSET CONSULTANTS

The NUC engaged Cosset Consultants to carry out post review of procurement activities of the 17 ACE-Impact Centres in fourteen (14) Nigeria Universities, including the ACE-MFS, Federal University of Technology, Minna, Niger State, Nigeria.

2.9 METHODOLOGY

1. The methodology adopted for this assignment is generally concerned with investigations, inquiry, assertions, reasoning and research. The approach is objective, verifiable, and quantifiable. Interactions and interviews were held with officers of ACE-MFS that were involved in the various stages of the procurement process/activities. The opinions and clarifications from the ACE-MFS staff were considered and addressed in the report.

2. Contract data forms were used to collect the information that were analyzed. The contents of the form include information on general contracts, procurements and contracting, costs, time, contract administration, disbursement and deliverables. The documents made available to the consultant from which the data were collected include:

- 1. Procurement Plan.
- 2. Institution guideline.
- 3. Solicitation documents used before award.
- 4. Contract files.
- 5. Payment Vouchers.
- 6. Finance Agreement.

3. Visits to selected project site were undertaken to determine the quality of materials and labour deployed to the works by the contractor. It also helps to determine the level of supervision from the ACE-MFS procurement staff.

4. This data analyzed enabled the determination of the following critical success factors;

- 1. Compliances with the provisions of the World Bank Procurement Guidelines.
- 2. Compliances with the provisions of the Public Procurement Act 2007 (examine the Management Control Framework in place to monitor procurement and contracting activities within ACE-MFS PIU).
- 3. Compliances with the use of standard bidding documents (examine procurement documents and contracts files issued between the stipulated periods).
- 4. Compliances with the Code of Conduct for Public Officers involved in Procurement (review the processes undertaken by personnel of the ACE-MFS Project who are directly involved in procurement and contracting activities).
- 5. Optimized commercial performance and value for money (review related procurement procedures, guidelines and processes and determine the level to which value for money was achieved).

5. Exit meeting was held with the procurement staff of the Centre. The observed key weaknesses and non-compliances were brought to their notice. The explanation given by the Centre staff are considered in the report.

6. The personnel interacted with at the ACE-MFS during the field works were:

- 1. Center Leader
- 2. Deputy Centre Leader
- 3. Monitoring and Evaluation officer.
- 4. Accountant
- 5. Internal Auditor
- 6. Procurement Officer.

SECTION 3 – SCOPE AND REVIEW SAMPLES

3.1 AUDIT SCOPE

The procurement audit covers the review of all the procurement transactions, limited to the samples selected for audit, including prices reviews and compares of similar rates as at the time of award. Selected project site and inspection of procured goods, works and services are expected to be taken into consideration. The scope incudes determining the following:

- 1. Whether the procurement statements from the ACE-MFS procurement unit conform to accepted procurement principles in accordance with the NUC/WB guidelines.
- 2. Whether they fairly represent the financial position of the ACE-MFS activities
- 3 Whether the result of operations for a given period are accurately represented.
- 4. Whether the procurement statements have been altered.

3.2 **REVIEW SAMPLE**

During the field work, ACE-MFS presented their procurement plan with a list of fourteen (14) procured items. 10 (10) were completed, three (3) were ongoing while one (1) has award letter ready, but not yet issued to the approved supplier.

Seven (7) procurements were selected for review. The selection was 50% of the procured items and amount to about 65% of the value of procured contracts.

The field work at the ACE-MFS, was based on data sourced from available documents and information received from the Center procurement unit.

This audit review was based on information extracted from the Center's Procurement Plan, as well as other documents made available to the Consultant by the ACE-MFS staff. There were also interviews and interactions with key personnel. The value of the fourteen (14) contracts was N956,593,642.91



SECTION 4 - SPECIFIC CONTRACTS/PROJECTS DETAILS

4.1 CONSTRUCTION OF ACEMFS BUILDING

4.1.1 Introduction

This contract was procured through National Competitive bidding (NCB). The award was made to MESSRS MAHADI SERVICES & RESORT with an award letter dated August 18, 2022 at a contract price of N326,749,743.75 (Three Hundred and Twenty-six million, seven hundred seventy-five kobo). The award was made to the lowest bidder.

4.1.2 Observations/ Findings

4.2.2 In line with the NCB procedure, the following are the major observations in the procurement process leading to the award of this contract.

4.1.2.1 Procurement Planning

This contract is in the 2022 procurement plan.

4.1.2.2 Advertisement

The contract was advertised in the Federal Tenders' Journal of July 11, 2022.

4.1.2.3 Pre/Post Qualification

The contract amount is within the threshold for prequalification. Bidders were pre-qualified before proceeding to financial bids activities.

4.1.2.4 Competition

There was appreciable competition in the process.

4.3.2.5 Bid Opening

The bids were opened publicly in the presence of the Procurement Committee and some independent observers.

4.1.2.6 Bidding Documents

Standard bidding documents were used.

4.1.2.7 Evaluation of Bids/ Proposals

The bids were evaluated and analysed by the bid evaluation committee. There was minute of meeting where the approval was



issued by the University Tenders Board before award letter was issued to the successful bidder.

4.1.2.8 Award of Contract

Notification of award was issued to Messrs Mahadi Services & Resort with an award letter dated August 18, 2022. Acceptance was made on August 21, 2022.

4.1.2.9 **Contract Documents**

Contract drawings and Bills of Quantities were sighted. Contract Agreement was executed on September 8, 2022.

4.1.2.10 **Procurement Duration**

The procurement processes leading up to the signing of contract was completed in (fifty-nine (59) days. This is reasonably within limit.

4.1.2.11 **Contract Implementation**

The project is ongoing and the quality in terms of the materials and labour is commendable. The project supervision is satisfactory.

4.1.2.12 **Payments**

The total amount of N178,279,194.39 has been paid to the contractor as follows:

1. N42,041,798.75 - Interim Payment No.1 with (PV/2022/FUTM-1/086) of 16/9/2022 (including VAT-N2,983,148.75; TAX-N1,955,432.5).

2. N35,120,761.97- Interim Payment No. 2, with (PV/2022/FUTM-1/137) of 7/10/2022 (INCLUDING VAT-N2,450,285.72; TAX-N1,633,523.81).

3. N53,529,792.00 - Interim Payment No. 3 with (PV/2023/FUTM-1/013) of 19/1/2023 (including VAT - N3,754,636.65; TAX- N2,489,957.77; Stamp Duty N497,951.55) 19/01/2023).

4. N47,586,841.67 - Interim Payment No. 4 with (PV/2023/FUTM-1/068) of 9/3/2023 (INCLUDING VAT - N3,320,012.17; TAX-N2,213,341.45 Stamp Duty N430,053.45).

4.1.2.13 Physical Inspection

The project was inspected, and the completion was about 48%.



4.1.3 Recommendation

Based on the procurement audit process field work at the ACE-MFS, this project execution is commendable.

4.1.4 Conclusion

In view of the above observations and recommendations, ACE-MFS should continue with adhering to the rules, regulations and principles guiding the Public Procurement Process Management.

PROCUREMENT AND INSTALLATION OFULTRA HIGH PERFORMANCE LIQUID CHROATOGRAPHY AND IMMUNO-AFFINITY COLUMN

4.2.1 Introduction

4.2.

This is an NCB contract, but it was procured using Request for Quotation (RFQ) by selection based on "No Objection" approval from the BPP. The nature of the product is that it is not an off-the-shelf good. Eight (8) vendors were invited for the bid. It was awarded to MESSRS FONSOTS GLOBAL SERVICES LIMITED with the lowest bid of N95,449,045.08. The award letter was dated August 23, 2022.

4.2.2 Observations/ Findings

In line with the RFQ procedure, the following are the major observations in the procurement process.

4.2.2.1 Procurement Planning

This contract is in the 2022 procurement plan.

4.2.2.2 Advertisement

It was not advertised because RFQ, with was used based on No Objection approval from the BPP to use selection for the procurement.

4.2.2.3 Pre/Post Qualification

There was no Pre/Post Qualification. Bidders were invited to bid based on their possession of authorization from original equipment manufacturers (OEM) and on performance on past engagements with the University and elsewhere.

4.2.2.4 Competition

There was appreciable competition. The prices are within market average.

4.2.2.5 Bid Opening

The bids were submitted and opened in the presence of bidders and independent observers.

4.2.2.6 Bidding Documents

Standard bidding documents were used for the procurement.

4.2.2.7 Evaluation of Bids/ Proposals

The bids were evaluated, and approvals were made by the appropriate bodies before award letter was issued.

4.2.2.8 Award of Contract

The award was made to the lowest bidder. Notification of award letter was dated August 23, 2022 while the acceptance letter was dated October 28, 2022.

4.2.2.9 Contract Documents

The Contract documents that were available include the award letter and signed contract agreement.

4.2.2.10 Procurement Duration

The procurement process duration of 88 days, up to the signing of the Contract Agreement is not commendable.

4.2.2.11 Contract Implementation

The contract was well implemented up to this stage.

4.2.2.12 Payments

The payment seen to have been made was N28,634,713.52 (being 30% Advance Based on APG from Zenith Bank REF. ZOG151 - 22006012) dated 30/1/2023; with PV/2023/FUTM-1/029) of 30/1/2023.

4.2.2.13 Physical Inspection

Physical Inspection was not applicable at this stage.

4.2.3 Recommendation

(1) Acceptance of offer of award, after more than 60days should not be allowed to occur again. It has some legal implication and should be avoided.

(2) The Centre should always be seen to have used the SBD in all procurements. It helps to achieve value for money and robust competition. This would be done by providing them on request.



4.2.4 Conclusion

The primary attribute of good procurement is dependent on compliances with the procurement guiding principles. ACE-MFS should always strive to achieve that.

4.3. PROCUREMENT AND INSTALLATION OF POLYMER CHAIN REACTION (PCR) MACHINE – LOT 6 (FUTM/ACEMFS/GDS/NCB/2022/06)

4.3.1 Introduction

This is an NCB contract, but it was procured using Request for Quotation (RFQ) by selection based on "No Objection" approval from the BPP. The nature of the product is that it is not an off-the-shelf good. Eight (8) vendors were invited for the bid. It was awarded to MESSRS KATCHEY COMPANY LIMITED with the lowest bid of N98,912,703.78. The award letter was dated August 23, 2022.

4.3.2 Observations/ Findings

In line with the RFQ procedure, the following are the major observations in the procurement process.

4.3.2.1 Procurement Planning

This contract is in the 2022 procurement plan.

4.3.2.2 Advertisement

It was not advertised because RFQ, with was used based on "No Objection" approval from the BPP to use selection for the procurement.

4.3.2.3 Pre/Post Qualification

There was no Pre/Post Qualification. Bidders were invited to bid based on their possession of authorization from original equipment manufacturers (OEM) and on performance on past engagements with the University and elsewhere.

4.3.2.4 Competition

There was appreciable competition. The prices are within market average.

4.3.2.5 Bid Opening

The bids were submitted and opened in the presence of bidders and independent observers.

4.3.2.6 Bidding Documents

Standard bidding documents were used for the procurement.

4.3.2.7 **Evaluation of Bids/ Proposals**

The award was made to the lowest bidder. Notification of award letter was dated August 23, 2022. The letter of acceptance was dated October 3, 2022.

4.3.2.9 **Contract Documents**

The Contract documents that were available included the award letter and signed contract agreement.

4.3.2.10 **Procurement Duration**

The procurement process duration of 61 days, up to the signing of the Contract Agreement is not commendable.

4.3.2.11 **Contract Implementation**

The contract was being well implemented up to this stage of waiting for installation.

4.3.2.12 **Payments**

Payments made are as follows;

1. N29,673,811.13 (being 30% Advance Based on APG from Zenith Bank REF. ZOG068 -22006010) of 20/12/2022.

2. N49,456,351.89 (at delivery of items) on 30/03/2023.

3. Balance of 20% of the contract sum was retained for installation.

4.3.2.13 Physical Inspection

Physical Inspection was carried out and the good were seen stored in the laboratory -Appendix 5.

4.3.3 Recommendation

(1) Acceptance of offer of award, after more than 60days should not be allowed to occur again. It has some legal implication and should be avoided.

ROCUREMENT AUDIT OF ACE-IMPACT PROJECT OF ACEMFS, FUTM

(2) The Centre should always be seen to have used the SBD in all procurements. It helps to achieve value for money and robust competition. This would be done by providing them on request.

4.3.4 Conclusion

The primary attribute of good procurement is dependent on compliances with the procurement guiding principles. ACE-MFS should always strive to achieve that.

4.4 ENVIRONMENTAL AND SOCIAL MANAGEMENT PLAN FOR THE CONSTRUCTION OF ACEMFS CENTRE BUILDING

4.4.1 Introduction

Mr Joseph Galu Peter Agba was on September 20, 2022 awarded the contract for Consultancy Services to provide Environmental and Social Management Plan for the construction of ACEMFS Centre building, Federal University of Technology, Minna, at the sum of N5,675,000.00. During negotiations, the sum was reduced from the lowest evaluated tender sum of N6,156,795.00 to the award amount.

4.4.2 Observations/ Findings

In line with the method of procurement, the following observations were made:

4.4.2.1 Procurement Planning

The consultancy service was in the signed Procurement Plan.

4.4.2.2 Advertisement

Notice for Expression of Interest (EOI) for the Consultancy Service was placed on the Centre's Tender Notice board on June 6,2022.

4.4.2.3 Expression of Interest/Request for Proposal

Three (3) bidders were shortlisted from those that responded to the EOI notice and asked to submit proposals/bids.

4.4.2.4 Competition

The process was competitive.

4.4.2.5 Bid Opening

The bids received were opened on appointed day and subsequently evaluated

4.4.2.6 Bidding Documents

Bidding documents/ Proposals from the bidders were sighted.

4.4.2.7 Evaluation of Bids/ Proposals

Evaluation Report, though with no date, was sighted which recommended the most responsive bid for the award.

4.4.2.8 Awards of Contract

Notification of Award Letter was issued to Mr Joseph Galu Peter Agba dated September 20, 2022 at the negotiated sum of N5,675,000.00. his initial offer which was the lowest responsive bid was N6,156,795.00.

4.4.2.9 Contract Documents

The contract documents were the letter of award and the acceptance letter. The contract agreement was not sighted.

4.4.2.10 Contract Implementation

The contract implementation was satisfactory as it was completed as evidenced by Job Certification Order of October 18, 2022.

4.4.2.11 Payments

A total of N5,675,000.00 including VAT, WHT) fee was paid once to the consultant on February 23, 2023.

4.4.2.12 Physical Inspection

Not applicable

4.4.4 **RECOMMENDATION**

- Dates of critical activities during the procurement process must always be recorded. This, among other things, facilitates the calculation of procurement durations in any procurement.
- 2. Dully signed Contract Agreement should always accompany all contract awards.

4.4.5 CONCLUSION

The contract was successfully executed with no time overrun. There was a saving of N481,795.00 by awarding the contract at a sum lower than the Lowest Evaluated Tender sum of N6,156,795.00 and the Consultant accepted.

4.5 PROCUREMENT AND SUPPLY OF LAPTOP COMPUTERS FOR ACEMFS NANO TECHNOLOGY RESEARCH TEAM MEMBERS

4.5.1 Introduction

This goods contract for the supply of 3 No. Apple MacBook Pro 13.3" 16GB -8cores laptop computers to ACEMFS, Federal University of Technology, Minna, for use by NANO Research Team members. With the "NO OBJECTION" granted by the BPP, four (4) selected vendors were issued RFQ for the supply and they all responded. The contract was awarded to NUGALINKS INTEGRATED SERVICES on February 6, 2023 at the sum of N8,745,317.00.

4.5.2 Observations/ Findings

The following observation were made regarding the procurement

4.5.2.1 Procurement Planning

This procurement is in the 2022 World Bank approved Procurement Plan for the Center.

4.5.2.2 Advertisement

Tender Notice was placed on the Centre's Notice Board. However, with the "NO OBJECTION" from BPP, four (4) selected vendors were issued RFQ and they all responded.

4.5.2.3 Pre/Post Qualification

The Vendors/Suppliers that were invited to submit quotations were selected based on their competence over time.

4.5.2.4 Competition

The procurement process was competitive and transparent.

4.5.2.5 Bid Opening

Bids were opened on February 6, 2023 at ACEMFS Conference room, with the bidders in attendance.

4.5.2.6 Bidding Documents

Standard Bidding Documents were used during the process.



4.5.2.7 Evaluation of Bids/ Proposals

Bid Evaluation Report, as sighted, recommended the lowest bidder, Nugalinks Integrated Services (N8,745,317.00) for award. Reserved price was N8,914,000.00.

4.5.2.8 Awards of Contract

Contract Award Letter Ref: ACEMFS/GDS/05/2023 dated February 6, 2023 was issued to MESSRS NUGALINKS INTEGRATED SERVICES at the sum of N8,745,317.00. Acceptance letter was received on February 6, 2023 while the Contract Agreement was signed on February 8, 2023.

4.5.2.9 Contract Documents

The contract documents include the letter of award, the acceptance letter, the signed contract agreement and the quotation.

4.5.2.10 Procurement Duration

Procurement duration for the award was 5 days.

4.5.2.10 Contract Implementation

The laptops were supplied and received in good condition as certified by Engr. Dr. Bala Salihu on April 14,2023.

4.5.2.11 Payments

Payment for the supply was made once and in full to Nugalinks Integrated Services to the sum of N8,745,317.00 (including VAT, WHT) on April 14, 2023 with PV/2023/FUTM.

4.5.2.12 Physical Inspection

The laptops were inspected and certified by Engr. Dr. Bala Salihu on April 14, 2023.

4.5.3 Recommendation

It could be stated that the Centre was fair in the entire process, but they are encouraged to still improve.

4.5.4 Conclusion

The procurement exercise was commendable.

4.6 PROCUREMENT AND SUPPLY OF LAPTOP COMPUTERS FOR ACEMFS FINANCE OFFICERS.

4.6.1 Introduction

The contract was procured through National Shopping for the supply of 2 no. OMEN by HP Laptop 16-b0061nia and 2 no. Apple MacBook Pro 13.3" 16GB -8cores laptops for use by ACEMFS Finance Team, Federal University of Technology, Minna. The contract was awarded to Messrs JAYKIM-KUSIN LTD at a contract sum of N9,714,630.95 on April 6, 2023.

4.6.2 Observations/ Findings

The following observation were made regarding the procurement

4.6.2.1 Procurement Planning

The contract was in the approved 2022 Procurement Plan.

4.6.2.2 Advertisement

Notice was placed on the Centre Tender Notice board. Four (4) submitted quotations (Financial bids) to this effect for consideration on February 6, 2023.

4.6.2.3 Pre/Post Qualification

There was no prequalification exercise. The Vendors/Suppliers that were invited to submit quotations were selected based on their competence over time.

4.6.2.4 Competition

There was good competition in the process.

4.6.2.5 Bid Opening

The tenders were opened on April 5, 2023 at ACEMFS Conference room and figures as submitted together with completion periods were announced. The Reserved Price of N9,800,650.00 was equally announced.

4.6.2.6 Bidding Documents

Standard Bidding Documents were used during the process.

4.6.2.7 Evaluation of Bids/ Proposals

Bids Evaluation Report April 5, 2022, as sighted, recommended M/S JAYKIM-KUSIN LTD as the lowest and most responsive bidder for the award.

4.6.2.8 Awards of Contract

Notification of Award Letter was issued to JAYKIM-KUSIN LTD on April 6, 2023 at the sum of N9,714,630.95. Acceptance letter was received on April 6, 2023 and Contract Agreement signed on April 10, 2023.

4.6.2.9 Contract Documents

The contract documents include the letter of award, the acceptance letter, the signed contract agreement and the quotation.

4.6.2.10 Procurement Duration

The procurement process duration (between RFQ and Award took a long time of 64 days.

4.6.2.11 Contract Implementation

Contract implementation was satisfactory as the items were certified by Engr. Salihu on April 11, 2023

4.6.2.12 Payments

Upon inspection and certification of the laptops, full payment of N9,714,630.95 (including VAT, WHT) was made to the supplier, M/S JAYKIM-KUSIN LTD, on April 14, 2023 via PV/2023/FUTM-1/00000098.



4.6.3 Physical Inspection

Some of the laptops were sighted.

4.6.4 Recommendation

From the audit exercise, the procurement process was credible. Nevertheless, there is always room for improvement.

4.6.5 Conclusion

In view of the above observations and recommendations, the Center should be encouraged to still improve by adhering strictly to the rules and regulations guiding the public procurement management.

4.7 PROCUREMENT OF 1NO. 30- SEATER TOYOTA COASTER BUS FOR ACEMFS, FEDERAL UNIVERSITY OF TECHNOLOGY, MINNA.

4..7.1 Introduction

This was a contract for the procurement of 1no. 30- seater Toyota Coaster bus for transporting local and foreign post graduate students of ACEMFS procured through NCB and awarded to MESSR INEH-MIC AUTOMOBILE Co LTD on January 13, 2023 at the contract sum of N77,850,000.00. It was initially awarded, after proper Tender exercise, at the cost of N64,695,000.00 to GLOBE MOTORS LTD. The contractor declined to continue because of market price increases.

5.1.2 Observations/ Findings

The following observations wer made with the procurement

4.7.2.1 Procurement Planning

The procurement was in the signed 2022 Procurement Plan.

4.7.2.2 Advertisement

The BPP granted approval fpr No Objection and so, Requests for Quotation were sent to selected dealers.

4.7.2.3 Pre/Post Qualification

Requests for Quotation (RFQ) were sent to selected auto dealers based on their track records and capabilities.

4.7.2.4 Competition

The process was reasonably competitive as the four (4) bidders submitted their individual quotations from which the most responsive was awarded the contract.

4.7.2.5 Bid Opening

Four quotations, as received, were opened on August 8, 2022 in the presence of the bidders.

4.7.2.6 Bidding Documents

Standard Bidding Documents were used during the process.

4.7.2.7 Evaluation of Bids/ Proposals

After the bids opening, the most responsive bidder was recommended for the award.

4.7.2.8 Awards of Contract

Notification of Award Letter was issued to MESSRS INEH-MIC AUTOS CO LTD on January 13, 2023 at the contract sum of N77,850,000.00. Acceptance letter was received on January 19, 2023 but no signed Contract Agreement.

4.7.2.9 Contract Documents

The bidder's quotation which also states term of the offer and the contract award letter were the contract documents

4.7.2.10 Contract Implementation

The implementation of the contract was satisfactory as the contract was completed on January 24, 2023.

4.7.2.11 Payments

The bus was supplied in record time, certified and payment to tune of N77,850,000.00 made to the contractor on February 1, 2023. (including VAT, WHT). PV not sighted.

4.7.2.12 Physical Inspection

The team inspected the vehicle and picture is attached.

4.7.3 Recommendation

- Procurement Unit should ensure that signed Contract Agreements accompany every contract. These would always provide something to fall back on should disputes arise during any contract.
- 2. Bid Validity Period need to be emphasized and introduced always during tendering to check frivolous calls for cancellation by contractors on grounds of increase in prices.



4.7.4 Conclusion

In view of the above observations and recommendations, the Center should be encouraged to continue to adhere strictly to the rules and regulations guiding the Public Procurement Procedures and Management.



Section 2015 PROCUREMENT AUDIT OF ACE-IMPACT PROJECT OF ACEMFS, FUTM


















APPENDIX 5 TERMS OF REFERENCE

3.1 TERMS OF REFERENCE

The Terms of Reference (TOR), the WB Procurement Guideline, the Public Procurement Act 2007 and the Public Service circular relating to the Procurement practice within the University is the guiding framework for the post procurement review. Key procurement processes were considered including:
